**WHEREAS**, the Board of Commissioners can delegate authority to the County Administrator to execute and sign grant applications and accept awards; and


**WHEREAS**, Lane County Emergency Management has been invited to apply for State Homeland Security Grant funds on behalf of all eligible applicants in Lane County; and


**WHEREAS**, the State Homeland Security Grant requires four forms to be signed by the County Administrator as part of the grant application package






