- Admin** Deliver or pick-up supplies, equip, veh maint, paperwork, DB enclosure inspects, etc.
- Dispatch** Citizen complaint, request for service
- AWO Int** Animal Welfare Officer initiated the call. ex: while on general patrol, picked-up a loose dog or he was flagged/contacted by a citizen while in the field
- Contact** Contact with someone in person (citizen, dog owner, complainant, Vet)

- Citations** Issued - there may be more than one violation on each cite - stats are counted for each violation
- License New** Mailed out letters advising dog owners we have received their dogs rabies record & they need to purchase a license
- License Renewal** Mailed out letters advising dog owners their existing license and/or rabies is expired, or will expire within 30 days
- RTO** Return to owner Ex: picked-up a dog running loose and returned home to owner without having to impound
- Bites** Code required report of a bite resulting in skin breakage. Some may include a dispatch call for a Dangerous Behavior complaint.
- DB New** Dangerous Behavior, new formal complaints processed/citation issued
- Voucher** Approved and processed, not necessarily used
- Voucher** Used, submitted for payment to LCAS (from Vet)
- Impounds** Includes DOA's (dead on arrival)
- PR** Public relations. An informal request for contact to 'talk' to a citizen about an issue. Complainant doesn't want a ticket issued.

**Note 2:** Dog at large counts may be for dogs injured, in traffic, or loose/aggressive with no known owner. Doesn't include general patrol while in area.  
**Note 3:** Dispatch cards 'actual' counts are for the month they are completed.
