Dear Lane County Animal Services Staff:

On behalf of the Lane County Animal Services Advisory Committee, we want to sincerely thank you for your exemplary service and dedication during the Holiday Farm Fire. The Holiday Farm Fire burned more than 174,404 acres in Lane County causing the displacement of livestock, dogs, cats and other companion animals.

During the duration of the Holiday Farm Fire, LCAS visited over 331 property sites performing animal evacuation, transportation and providing food and water to animals sheltering in place. LCAS established a livestock shelter at the Lane Events Center for over 576 animals. The response and evacuation efforts headed by LCAS were largely successful due to the collaboration with a number of partners committed to a common goal. We would therefore also acknowledge Greenhill Humane Society, Lane County Animals in Disaster (LCAID), the Cities of Eugene and Springfield and Lane County Public Works as a part of this successful outcome.

The Lane County Animal Service's mission continues to be ensuring public and animal health, safety and quality of life within our community; and bringing about and maintaining an environment in which people and animals can live harmoniously. Again, thank you so much for your service during the Holiday Farm Fire.
